Vice President Laura Toy offered a motion to request input from the Livonia Chamber of Commerce.

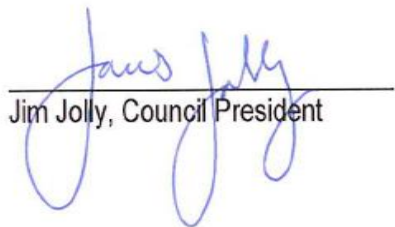
The Committee recommends the following resolutions:
