The Committee recommends:

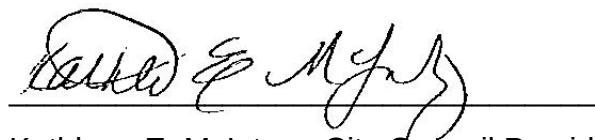
